

Changes are on the way

We're letting you know that monthly premiums for ING Living Super Income Protection cover with a benefit period to age 67 will increase from 8 January 2021.

We work closely with our insurer, MetLife, to ensure any price increases are as reasonable as possible, and we try hard to keep increases to a minimum. This is the first increase in premiums for Income Protection cover since 2015. The rise in this case is due to various external factors impacting the insurance industry, such as the low interest rate environment and the coronavirus disease (COVID-19).
