



Share Trading via Living Super - Changes to the S&P/ASX 300 index

On 4 March 2022, S&P Dow Jones Indices announced the results of the March 2022 Quarterly Rebalance of the S&P/ASX Indices for changes to be effective prior to the opening of trade on 21 March 2022.

To reflect the March 2022 Quarterly Rebalance, changes have been made to the availability of investments in the S&P/ASP 300 index via Living Super effective from 21 March 2022.

For shares listed in the 'Removals' group below, members with current investments in these shares can retain or sell them at any time, however members are not allowed to acquire further investments unless the relevant share is re-introduced into the index.
