

In October 2021, we changed the Living Super application form to include an investment objective questions to align with Design and Distribution Obligations (DDO) introduced 5 October 2021.

Based off our industry learnings, we are now taking the opportunity to simplify our application form by removing this investment objective question effective 24 May 2022.

The Trustee will continue to accept old forms until 23 June 2022. From 24 June 2022, the Trustee will only accept the new forms.
